Measure the required volume of REVVCARE® and pre-mix in at least 10 l of water before adding to the spray tank. Fill the spray tank with water to the final volume required while maintaining agitation to ensure thorough mixing of the spray mixture before spraying commences. Maintain agitation while spraying. Prepared spray mixture must not be left in the spray tank for any length of time, e.g. overnight.

CITRUS:

- Apply REVVCARE® as part of a preventive spray programme.
